**Sub: Outcome of Board Meeting dated 25<sup>th</sup> July, 2024.**

Pursuant to Regulation 30 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 and other applicable rules and regulations the Board of Directors at its meeting held on today i.e. Thursday, 25<sup>th</sup> July, 2024, has, inter alia, considered and approved the following items:

## **1. ALLOTMENT OF EQUITY SHARES PURSUANT TO CONVERSION OF WARRANTS**

The Board has accorded its approval/consent for issuance and allotment of 7,30,000 number of equity shares pursuant to conversion of 7,30,000 number of warrants convertible in to equivalent number of equity shares to the person(s) belonging to Promoter Group on preferential basis after receipt of balance amount of 75% against each warrant towards full and final subscription amount for conversion of same into equity shares.

Pursuant to above said allotment of equity shares allotted pursuant to conversion of warrants, the issued and paid-up Equity Share Capital of the Company stands increased to Rs. 17,09,65,970/- divided into 1,70,96,597 equity shares of face value of Re 10/- each.
